


# **Priority Waters**

- Step 3 was to assess how we could best partner with a public resource agency.


# Shenandoah National Park or George Washington National Forest?

- Opportunities for proactive instream habitat work are greatly limited by the historic NPS policies regarding human intervention in natural processes.
- Most Shenandoah Park waters exhibit stable to improving habitat conditions. Only a few Park waters (e.g., the Rapidan) face human-caused perils at present.
- The George Washington & Jefferson National Forest has a long track record in stream habitat restoration efforts.

The chapter's ad-hoc Priority Waters team visited two potential National Forest project streams in April ...


- Mill Run at Veach's Gap is a tributary to Passage Creek. The Forest Service and DWR successfully created a restoration brook trout population here in 2005.
- Little Passage Creek, also a Passage Creek tributary, has been limed seven times since 1987. It was deemed suitable for brook trout restoration in the 1990's.





# Which one to select?

- Your input will be valuable.
- Both streams are within an approximate one hour drive from Winchester.
- Both have existing, sustaining wild trout. Both have reasonably stable habitats.
- How should we proceed? What resource goals should we discuss with Forest Service?
- How long will our commitment be? And what will "success" look like?




Meanwhile, at Little Passage Creek.

- Clearly, some habitat work has been undertaken in the past.
- What worked? What lessons were learned?





A commitment to either will require long-term effort ... throughout the seasons.



# Some likely tasks may include..

- Placement and maintenance of temperature data loggers
- Photo documentation of habitat changes throughout the seasons
- Water quality sampling
- Documentation of other fish species (including notations about possible invasives)
- Moving rocks, moving logs, identifying existing sources of large woody debris (LWD)
- Close coordination with resource biologists ...
